

An Aging Nation

Over the next decade, the number of older adults will dramatically increase as the youngest baby boomers reach age 65.

By 2030, **1 in 5 (73 million)** Americans will be **65 or older**

Housing and Home Modifications/Repairs

86% of adults age 65 and older say they hope to stay in their homes for as long as possible.

To do so, many people will eventually need some level of service or support to live safely and successfully in their home or community.

Alzheimer's Disease and Dementia

Social Isolation and Loneliness

43% of older adults have reported feeling lonely and

27% report feeling isolated from others.

Social Determinants of Health



of older adults have at least **one** chronic disease



of older adults have at least **two+** chronic diseases **Research shows that social determinants of health** (e.g. access to nutrition, housing supports, or transportation) can prevent, delay or mitigate unnecessary and costly health care episodes.




About the National Survey of AAAs

- Funding through the U.S. Administration on Aging within the Administration for Community Living
- Conducted by n4a in collaboration with research partner: Scripps Gerontology Center at Miami University of Ohio
- Tracks important new trends in programs, services and funding affecting older adults
- Conducted every two to three years since 2007
- Survey responses were collected in 2019
- 79% response rate by AAAs


AAA Service Areas



Addressing Social Isolation

- Social isolation is addressed during care planning -50%
- Assess for social isolation 43%
- Assess for loneliness 36%
- Have established partnerships to address social isolation and social engagement - 24%
- Developing or have in place programs to specifically address social isolation and social engagement – 21%


61% provide home modifications and repair services

Home Modifications and Repair Services



Minor home modification installation (e.g., grab bars, raised toilets, handheld showers, handrails, lever door handles)


Repairs (e.g., roof, electrical, carpeting/floors, loose stair railings or other stair repairs)

Major home modification (e.g., remodel bathrooms, adjust counter/cabinet heights, ramps, elevator/platform or chair lifts, widen doorways, roll-in shower)

Home assessments (a systematic review of the home environment)

Delivery or coordination of other home modification or repair services

Transportation Services

- 51% of AAAs involved with an integrated care initiative provide transportation services;
- 88% of AAAs partner with transportation agencies;
- one in five AAAs receive transportation funding; and
- 40% of AAAs currently have a transportation coordinator or mobility manager on staff.

AAAs Serve a Broad Range of Consumers

78% Serve individuals younger than 60 who have a disability, impairment or chronic illness.



74% Provide programming targeted at people living with dementia and their caregivers.



52% Serve people with dementia of all ages (including under 60).

52% Offer programming to support the needs of grandparents caring for grandchildren.

Additional Programs Aimed at Specific Audiences

- Beyond programs for people with dementia and grandfamilies, AAAs have programs aimed at:
 - 66% individuals at risk of nursing home placement
 - 50% individuals who are Medicaid/Medicare eligible
 - 39% targeted to serve racial or ethnic minorities.
- Appears to be interest in developing programs to reach homeless individuals, individuals who hoard and individuals with substance abuse issues, but more funding/training is needed to do so


Evidence-Based Programs

- AAAs offer many types of evidence-based programs.
- Fall prevention programs are the most common, offered by 89 percent of AAAs.
- The second most common type of evidencebased program is chronic condition management programs, which 69 percent of AAAs offer.

Summary

- AAAs are addressing the needs of older adults and caregivers in their communities; many AAAs serve additional populations
- AAAs offer an average of 27 services in their communities meeting a broad range of needs, including transportation, housing & home modifications/repairs, and services to address social isolation
- AAAs broaden their reach through a variety of formal and informal partnerships, including partnerships with health care, transportation, and emergency preparedness/response agencies
- In addition to planning, coordination and delivery of services, AAAs are leaders at the community level through engagement and leadership in livable community initiatives

Area Agencies on Aging

Area Agencies on Aging (AAAs) operate in virtually every community in the nation with the mission to help older adults age with independence and dignity at home and in the community through a coordinated system of services and supports. Established by the Older Americans Act in 1973, there are 622 AAAs antionwide.

Budget and Steffing

Twelve of Alabama's 13 AAAs responded to the survey, resulting in a response rate of 92 percent? The makeup of Alabama's AAAs is varied. They are comprised of parts of councils of government or regional planning and development agencies (75 percent), independent nonprofits(17 percent) and other types of structures (sight percent). The average budget and stiff size of the AAAs that responded to the survey are listed below.
